**ORDER AUTHORIZING SUBSTITUTIONAL SERVICE

WHEREAS pursuant to section 17(2) of *The Financial and Consumer Affairs Authority of Saskatchewan Act* (the "**FCAA Act**"), the chairperson of the Financial and Consumer Affairs Authority (the "**Authority**") has appointed a panel (the "**Hearing Panel**") to hear this matter:

AND WHEREAS by virtue of section 17(7) of the *FCAA Act*, a decision or action of the Hearing Panel in relation to this matter is the decision of action of the Authority;

AND WHEREAS by way of an Order pronounced January 31st, 2023, service by way of registered mail to 510 Highlands Terrace, Saskatoon, Saskatchewan, S7H 4Y6 was authorized by this Hearing Panel;

AND WHEREAS service by way of registered mail to 510 Highlands Terrace, Saskatoon, Saskatchewan, S7H 4Y6 was attempted but not able to be effected;

AND WHEREAS after hearing oral submissions from Counsel for the Securities Division and reviewing written materials from Counsel for the Securities Division, cogent evidence has been heard in this matter that it is not practicable to serve the Respondent in this matter;

IT IS HEREBY ORDERED, pursuant to the provisions of ss. 1.4.2 and 3.8 of Saskatchewan Policy Statement 12-602 that:

This Motion be heard without notice to the Respondent; and

Service of the Notice of Motion dated February 14th, 2023, the Affidavit of Brett Wawro dated January 10th, 2023, the Brief of Law dated January 10th, 2023, and the Affidavit of Russell Del Rosario dated February 14th, 2023 and all Notice and or other process arising from this Motion on the Respondent is waived;

IT IS FURTHER ORDERED that:

Pursuant to the provisions of section 156(1)(c) of *The Securities Act, 1988*, SS 1988-89, c S-42.2, service of the Notice of Application dated May 11th, 2022, Affidavit of Brett Wawro dated May 11th,

2022, Brief of Law dated May 12th, 2022, Order dated September 16th, 2022, Order, dated October 7th, 2022, and all future process in this matter be effected by way of affixing any materials required to be served on the door of the residence located at 510 Highlands Terrace, Saskatoon, Saskatchewan, S7H 4Y6;

IT IS FURTHER ORDERED that:

This matter is adjourned *sine die*; and

Any party to this proceeding may schedule a further appearance on this matter by providing a request in writing for the same to the Registrar.
